Dues subsidize Fleet Operations: USRowing Dues, Liability & Boat Ins, Storage, Vehicles + equip. maint.

SeatFees: Fleet usage requires SeatFees sold in 5, 10 & 20 session packages. DropIn sessions are prorated based on the highest current PricePoint. **Development/H.S.:** NonMembers \$250, 450 & 850, Members: \$250, 400 & 750. **Master's:** Paying 50% of Annual Dues by Nov 30th & 50% again by Mar 15th qualifies for WAIVER of Mar, April & Nov SeatFees. SeatFees are also WAIVED once the SeatFee Max* of \$750 is reached. PunchCards are \$240(AnnMem)/\$320(other) for 10 sessions or \$550(AnnMem)/\$750 (Other) for UNLIMITED Annual SeatFees. **BONUS:** a single PunchCard may be credited toward Unlimited SeatFees. *Single Sculls: Due to the high cost of Singles, *an additional \$10 per session is added to SeatFees (0-\$32)* for both Members/NonMembers. Contact us about Private/SemiPrivate or Group rates.

High School Practice Fees/Costs: ARC Competitive Spring or Fall coaching Fees \$1450 Fall (Deposit: \$750 Fees+Fleet Dues+required TeamWear), MyBody Dryland & Practice rowers require PunchCards. Regattas & Clinics are billed per event *separately* based on costs, entry fees, travel & boat transport expenses. *Each event, regatta or clinic has varying costs based on location (distance), each event's entry fees, lodging & boat transport (Fuel, Tolls).
